## New Leadership Institutes

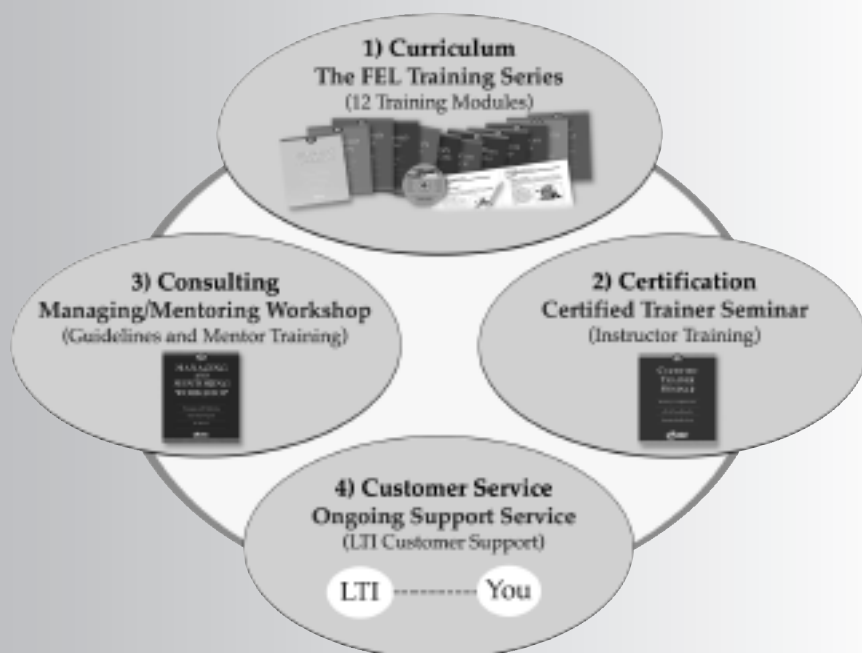
We welcome several new members to LTI's growing Association of Authorized Institutes:

### Starting Your Own Leadership Institute

Here are the simple steps needed to start your own onsite leadership institute:

- 1) Learn about the LTI System™.**  
LTI is now providing four yearly Taste and See Open Houses for key leaders at our Model Sites in Virginia (9:00a.m.-1:00 p.m.). This allows Senior Pastors and key decision-makers to see an actual institute in action.
- 2) Commit to become an Authorized Institute.**  
LTI has created a one-year agreement and membership fee to become a member of our Association of Authorized Leadership Institutes. The agreement spells out the benefits, costs, and implementation items for your institute.
- 3) Choose one of our training structure options.**  
LTI offers five training structure options for how you can operate your institute. Our experience has shown that we know what format and measurements are required for effective results.
- 4) Get your Instructors certified.**  
LTI allows up to four instructors from an Authorized Institute to become certified at any one of our quarterly two-day CT Seminars held in Virginia.
- 5) Attend the Managing & Mentoring Workshop.**  
LTI allows two administrators to attend the Managing & Mentoring Workshop at any of our quarterly workshops held in Virginia. This workshop covers the guidelines for success and teaches the mentors how to run the small groups portion of your training.
- 6) Choose your mentors and learners.**  
It is critical to establish who will participate in the institute as a learner and as a small group mentor well in advance. We require that each person who enrolls commits to complete all 12 modules of the whole LTI System™.
- 7) Begin your training!**  
Now you are ready to begin a training process that will typically be a two-year journey. Get ready to reproduce and multiply leaders!
